

Introduction

The Florida Emergency Preparedness Association (FEPA) Strategic Plan is a-two-year guide spanning 2024-2025 that sets a course of continuous improvement and establishes the major programmatic, policy and performance goals for FEPA. The Strategic Plan marks FEPA's commitment to continue to serve our membership as Florida's Premier Association of Emergency Managers.

Purpose

This planning document serves as the strategic vision for the progression of FEPA's desire to promote a professional emergency management organization comprised of emergency managers from the public, non-governmental, and private sector; promote professional expertise through training and best practices; enhance the effective management and operation of professional emergency management programs and services throughout the state of Florida; and to study, research, collect, compile, and disseminate information about effective emergency management processes and related functions.

This strategy comprises a series of goals, objectives and tasks intended to provide a clear, and measured approach towards a phased implementation of the vision. For each goal statement, a set of objectives is presented as key components to achieve the desired result. For each objective, a series of tasks are developed to provide a systematic set of actions to accomplish each activity.

While the goals, objectives and tasks are all interconnected, the availability of resources and operating environment will affect each time frame for completion differently. In some cases, progress can continue even if certain parts are delayed; while in other cases, a delay in one-component will delay the completion of the entire goal. No document or strategy can anticipate every issue, and new, unexpected challenges will always arise.

Mission Statement

To provide an educational network between emergency managers and their partners at the federal, state, county, municipal, tribal, volunteer, and private industry level, on critical emergency management issues.
